3. Incentive qualification reports will be available on GWIC agent portal.
4. Qualifying policies include GWIC's Final Expense insurance product.
5. GWIC reserves the right, in its sole discretion, to cancel or change the incentive program rules at any time. This incentive is just for Integrity agents who are contracted with GWIC.
6. Agents must remain in good standing and be actively contracted with GWIC at the time of payout.
