#### - BREAK-OUT PARTNER BONUS: REQUIREMENTS & GUIDELINES -

When a new full partner is created forcing a full partner above them to be out of the hierarchy, Integrity will pay a 2% bonus based on the net premium written by the full partner under his hierarchy up to 3 partners deep. This bonus will be paid monthly.

The full partner being overridden, must maintain a minimum of 75k per week over an 8 week period as outlined in the path to prosperity. If the production from the full partner being overridden is reduced below 75k per week during an 8 week period, the bonus is reduced to 1%. If the production is reduced below 50k per week averaged over an 8 week period, the bonus will be reduced to zero until the production has increased back to a minimum of 50k per week.

The overridding Executive Partner will pay and additional 1%, the full partner being overridden up to 3 partners deep, must maintain a minimum of 100K per week net over an 8 week period as outlined in the path to prosperity. If the production from the full partner being overridden is reduced below 100k per week during an 8 week period, the bonus is reduced to zero, The bonus will remain zero until the production has increased back to a minimum of 100k per week.

All other Path to Prosperity rules and guidelines for reaching partner level will remain in effect.

Net production is calculated by subtracting cancelled production from gross production. This is a program summary and does not contain all the program information and requirements. It is the agent's responsibility to request the increase in compensation by submitting the proper paperwork to the NASB headquarters. The maximum credit per sale is \$5,000 for promotion purposes; this does not affect commissions earned. Promotion guide can be altered or discontinued at any time by the company. The structure outlined above is based upon the primary carrier(s) compensation. Other carriers and products compensation may vary. Any disputes related to the Promote guide will be resolved at the sole discretion of the company as well as changes of the program.
