If you're familiar with our current SIWL eApp portal for our SimpliNow Legacy<sup>®</sup> product available through Connex – then this will be a user friendly and intuitive change. We've now added GIWL to the same eApp process. **Please note the legacy GIWL application portal will be discontinued on 11/18/2024.** After this date, the SIWL and GIWL eApp will only be accessible via Connex, and a registered Connex account will be required. ## Check out these three important changes in our new application process:

### Ability to select your product upfront

You can choose our SIWL product – SimpliNow Legacy® – if you believe the client can medically qualify for level or graded coverage. However, if you know the client is ineligible for SIWL, you can now select GIWL on the same application portal. It's completely up to you!

### Easier pivot from SIWL to GIWL

Not every client will qualify for SIWL. If a client answers 'yes' to a knockout question or has medical impairments that weren't disclosed upfront, it can lead to an unexpected decline – and you'll learn why. Now instead of jumping to a separate GIWL eApp website, you can easily pivot to a **GIWL application in the same platform**, if you and your client choose to do so.

### Save time with a pre-filled GIWL eApp

The most impactful change with this process enhancement happens when you start the SIWL eApp, and the client doesn't qualify. If they are eligible for GIWL, and you're ready to proceed with creating a GIWL eApp, it only takes a few clicks. From the **Underwriting Results** screen, click "**Save & Next**", then on the **Product Eligibility** screen, click "**Create My Guaranteed Issue Whole Life Application**". Once you see that your GIWL eApp has been created, click on "**My Cases**" on the upper right of your screen to **locate the converted to GIWL case**, complete the remainder of the GIWL eApp with your client, and submit! Easy as that!
